Bab 7 membahas mengenai konsinyasi, ini pun masih relevan dengan kondisi ekonomi sekarang dimana masih banyak kegiatan bisnis yang dilakukan dengan cara konsinyasi, baik bersifat sementara atau memang proses bisnisnya harus dilakukan dengan cara konsinyasi.
