during the Civil War, fighting for both the U.S. Army and the Confederate Army - two Harlan soldiers from the North, and two from the South, all killed together at the Battle of Bull Run; how Harlan Quakers ran key Safe Houses for the Underground Railroad that Harriet Tubman's escapees stayed in; how the daughter of U.S. Senator James Harlan married the son of President Abraham Lincoln; why there are two U.S. Supreme Court Justice John Marshal Harlans; why there is an African American branch of the Harlan Family, and a Latin American branch, and a Native American branch (with Harlan cousins still living on the Omaha Indian Tribe Reservation), a British branch, and an Irish branch of the family - who built the most famous ship in the world, the Titanic! There was a Congressman Harlan, a Judge Harlan, a General Harlan, and a Major Harlan of the U.S. Army back in the Cowboy Days who was Court Martialed for being a horse thief! And of course the sweet young lady Harlan for whom the song "O Home on the Range" was written. All this and much

Since the success in chemical induction of cancer in rabbit's ear skin by K. Yamagiwa in 1915, oncologists of the world have come to believe that they can only solve their problems by means of animal experimentation. The importance of environmental factors became more evident in 1935 when T. Yoshida and T. Sasaki introduced azodye hepatocarcinogenesis in rats. In the domain of the gastrointestinal tract, T. Sugimura has more recently accumulated enough evidence to indicate that locally active chemical mutagens are carcinogenic. In contrast, principal approaches to colorectal tumors have been quite different: emphasis has been placed on gene identification. Long before cancer of the large bowel was recognized, importance of the roles of adenomatosis coli and its familial occurrence attracted the

attention of epidemiologists and geneticists. Morphological characterization and analysis of hereditary trends of human material have already had a long history, and recently detailed analysis of genetic material has become feasible in the wake of rapid development in our knowledge of the oncoviruses, oncogenes, suppressor genes, chromosomal and DNA mapping, molecular mutation and so on. It is true that in colorectal pathology, and in no other field, these areas of research have been explored more extensively and decisively. The identification of previously ill-defined lesions such as precancers and benign neoplasms have been improved because sequential changes can be observed in multiple samples spread over a wide area and followed up in due course.

Reevaluates the relationship between mental disorders and disability, asserting that research into disability and impairment would benefit from the diagnosis of mental disorders be uncoupled from a requirement for impairment or disability to foster a more vigorous research agenda on the etiologies, courses, and treatment of mental disorders as well as

disabilities and to avert unintended consequences of delayed diagnosis and treatment. Examines the importance of culture in psychopathology and the main cultural variables at play in the diagnostic process, stating that training present and future professionals in the need to include cultural factors in the diagnostic process is a logical step in any attempt to develop comprehensive research programs in psychology, psychiatry, and related disciplines.
