Education and the Struggle for National Liberation in South Africa NYU Press

This book describes and documents the development of Danish support to national liberation in Southern Africa and the two-

sided humanitarian and political character of this support. It is based on previously restricted Danish ministry records and on NGO archives and interviews. The Nordic countries were unique in the Western world in their support to individuals, organisations and refugees, struggling to end institutionalised colonialism and racism and alleviate their humanitarian consequences. Nordic support was humanitarian and civilian, and to a large extent was given to refugees and to education. Increasingly, it came to involve national liberation movements and financial support to their civilian activities, at a time when these

movements were politically and militarily struggling against the regimes in their countries-including the government of Portugal, a NATO military partner of Norway and Denmark. Danish support developed differently from that of the other Nordic countries. Official support was never given directly to liberation movements. Rather, Danish NGOs were employed to advise on Danish allocations and to distribute these allocations and carry out activities, using their own capacity or through their international networks. In the field of sanctions, Denmark shifted from a policy of awaiting a UN Security Council decision to

imposing unilateral trade sanctions as the first Western country to do so, and the book analyses the political developments behind this. The study seeks to determine the events, rationales, arguments and decisions that led to the various forms of Danish support. Key questions are how Danish support was established as a purely humanitarian facility that later developed into supporting also the liberation movements, and how boycott was first considered to be an issue for the individual but eventually became national, official policy.  Transitional justice studies typically focuses on how nations remember, face and deal with histories of past violence. This book, however, shifts the frame from national discourses of transitional justice onto local memory actors who attempt to engage with these broader systems of meaning from below. The case study is based on the memory struggles of individuals and groups who are attempting to gain access to the discourses and benefits associated with dominant memory identities of 'victim'

and 'veteran' in the context of post-transition South Africa. They share a common history of squatter resistance in the Western Cape in the 1980s and a common struggle for inclusion in dominant memory frameworks. The main theme of this book is the politics of memory, as it relates to the conversation between national and local memory. Integrated within this theme is the further theme of alternative histories and counter-memories of struggle from below. In focusing on counter memories of violence and transition this book aims to tell a different version of South African liberation history in relation to the dominant narrative. It analyses local memory actors'

attempts to bring their lived histories into conversation with national discourses of reconciliation and the national liberation struggle. In doing so it unpacks a memory paradox occurring within these narratives, which highlights the politics of inclusion and exclusion within the frames of transitional justice knowledge. On the one hand this alternate story exposes the paradox between local and national memory while on the other hand it brings into focus the local experience of the intersection between international transitional justice discourses and national transition politics. This book will be of local and international interest to scholars and students in the field of

transitional justice, memory politics, national liberation struggle and South African historiography. It will also be of interest to a broader South Africa public, as it offers a deeper understanding of South Africa's history, which challenges taken for granted transitional justice frames of knowledge.

This book documents and analyses the involvement of Norway in the liberation struggle in Southern Africa. Apart from focussing on the formulation of official policies and the extensive cooperation with the liberation movements in the field of humanitarian

In 1969, the Swedish parliament endorsed a policy of direct assistance to the liberation movements in Southern Africa. Sweden thus became the first Western country to enter into a relationship with organizations that elsewhere in the West were shunned as "Communist" or "terrorist." This book—the first in a two-volume study on Sweden & the regional struggles for majority rule & national independence—traces the background to the relationship. Presenting the actors & factors behind the support to MPLA of Angola, FRELIMO of Mozambique, SWAPO of Namibia, ZANU & ZAPU of Zimbabwe, & ANC of South Africa, it addresses the question

why Sweden established close relations with the very movements that eventually would assume state power in their respective countries. The second volume (later this year) will discuss how the support was expressed, covering the period from 1970 until the democratic elections in South Africa in 1994.

This book explores the role of social movements in the Southern African liberation struggle, through the lens of two 'everyday communists'. Focusing on the Communist Party of South Africa (CPSA), the author explores the lives of

Ivan and Lesley Schermbrucker, whose contribution to the party was more clandestine than that of leaders such as Bram Fischer and Joe Slovo. They represent how 'ordinary' people could play significant roles based on stances more rooted in common decency and morality than in Marxist theory. The book also sheds light on the interplay between transnational and national tendencies during the liberation movement, particularly between the 1940s and the 1960s. The Schermbruckers changed their views in response to the shifting national and international political landscape, the rise of Stalinism, and the flight of South African

activists into exile from the 1960s. Both fluent in African languages, they were able to create relationships of trust with African members of the CPSA. Examining tensions and conflicts during the liberation struggle, this book provides fresh insights into 'underground' activism.

Transnational Histories of Southern Africa's Liberation

 Amilcar Cabral, who was the Secretary-General of the African Party for the Independence of Guinea and the Cape Verde Islands (PAIGC), was assassinated by Portuguese agents on January 20, 1973. Under his leadership, the PAIGC liberated

three-quarters of the countryside of Guinea in less than ten years of revolutionary struggle. Cabral distinguished himself among modern revolutionaries by the long and careful preparation, both theoretical and practical, which he undertook before launching the revolutionary struggle, and, in the course of the preparation, became one of the world's outstanding theoreticians of anti-imperialist struggle. This volume contains

some of the principal speeches Cabral delivered in his last years during visits to the United States. The first is his speech to the fourth Commission of the United Nations General Assembly on October 16, 1972, on "Questions of Territories Under Portuguese Administration." His brilliant speeches on "National Liberation and Culture" (1970) and "Identity and Dignity in the Context of the National Liberation Struggle" (1972) follow.
